

Directions to Terrill Middle School

From I-78 West:

- Get off I-78 West at Exit #41 (Berkeley Heights - Scotch Plains).
- At stop sign at bottom of ramp, turn right and go to traffic light (Plainfield Ave.); turn right.
- Proceed on Plainfield Ave. (becomes Bonnie Burn Rd.) to the 2nd traffic light; proceed through the light and bear right onto Route 22 West.
- Exit right off Route 22 West at sign for Terrill Rd. in Scotch Plains (Sears store on corner on left).
- Cross Route 22 and proceed about 2 miles on Terrill Rd. through 6 traffic lights, past United Methodist Church and Evangel Church (both on left), to Terrill Middle School (on left).

From I-78 East:

- Get off I-78 East at Exit #41 (Scotch Plains - Berkeley Heights)
- At the stop sign at the top of ramp, turn left and go to traffic light (Plainfield Ave.); turn right.
- Proceed on Plainfield Ave. as above.

From Route 22 West:

- Exit right off Route 22 West at sign for Terrill Rd. in Scotch Plains (Sears store on corner on left).
- Cross Route 22 and proceed about 2 miles on Terrill Rd. through 6 traffic lights, past United Methodist Church and Evangel Church (both on left), to Terrill Middle School (also on left).

From Route 22 East:

- Exit Route 22 East by turning right onto Terrill Rd. in Scotch Plains (Sears store on right).
- Proceed about 2 miles on Terrill Rd. through 6 traffic lights, past United Methodist Church and Evangel Church (both on left), to Terrill Middle School (on left).

From the Garden State Parkway:

- Get off the GSP at Exit# 135 (Westfield, Clark), exiting onto Central Ave., following signs for Westfield. (Note: For GSP northbound, go 3/4 around circle; for GSP southbound, use right exit lane and proceed directly.)
- Proceed on Central Ave. to the 1st traffic light (Raritan Rd. in Clark); turn left.
- Proceed on Raritan Rd. (becomes Oak Ridge Rd.) to the 4th traffic light (Lake Ave., liquor store on left); turn right.
- Proceed on Lake Ave. (becomes Martine Ave. Extension) to the 4th traffic light (Raritan Rd. in Scotch Plains, Center for Hope Hospice on left); turn left.
- Proceed on Raritan Rd. past Union County Vo-Tech (on left); road will become Terrill Rd.
- Continue through traffic light at Cooper Rd., past Parker Greenhouses (on right), to Terrill Middle School (on right).
