BOARD PRESIDENT'S ANNOUNCEMENT

INSTRUCTIONAL UPDATES

Dr. Mast introduced the Girls Varsity Tennis Team and praised them for such a remarkable, successful year and acknowledged that their commitment helped develop their expertise. Tennis Coach, Luke Piede commended this group of incredible girls for their ability to focus, persevere, and make history.

WHEREAS, the 2021 Varsity Girls' Tennis Team had the most remarkable season in the history of Girls' Tennis at Scotch Plains-Fanwood High School; and,

WHEREAS, the team placed 3rd overall at the Union County Championships at Hubstine Field in Plainfield at the end of September. Following an outstanding showing at the County Championship, the team earned the 3rd seed in the North II Group III Sectional Tournament, hosting Belleville on September 30th and Cranford on October 5th, both matches decidedly won by Scotch Plains-Fanwood 5-0; and,

WHEREAS, the team traveled to Chatham in the Semi-Final round and overcame a tough Cougar program by winning 3-2, which included a match that had to be completed the next day. On October 12th, the Raiders traveled to perennial champion, Millburn and earned a 3-2 victory and the first North II Group III Sectional Title since 1996; and,

WHEREAS, on October 14th, the Raiders traveled to Mercer County Park to face Mainland High School, the South Group III Champion and fought to a 3-2 victory and after a few hours rest, faced off with the North I Group IIII Champion Tenafly; and,

WHEREAS, the Varsity Girls' Tennis Team defeated Tenafly by a score of 4-1, earning the first Group III Title in the history of Scotch Plains-Fanwood Varsity Girls' Tennis; and,

WHEREAS, the 2021 Girls' Varsity Tennis Team was comprised of the following athletes:
