- He/she is a registered voter in the district.

NO BOARD OF EDUCATION MEMBER SHALL BE DIRECTLY OR INDIRECTLY INVOLVED IN ANY CONTRACT WITH, OR CLAIM AGAINST THE BOARD.

- ** Within 30 days of election or appointment to the board, a member must undergo a <u>criminal history background</u> investigation through the New Jersey Department of Education.
